In the event of any litigation arising out of or relating to this agreement, I (we) agree the hearing locale for any such lawsuit will be Pointe Coupee Parish Court. In the event of any claim for defective material, Fontaine Lumber Company will replace any material proven defective by applicant for a period of 90 days from manufacturer and no claim may be brought against Fontaine Lumber Company.

PERSONAL GUARANTEE: The consumer hereby unconditionally guarantees, at all times, full and prompt payment, within terms, of any indebtedness that may be incurred by commercial consumer applying for credit.
